

Chapter 108

PARKS AND RECREATION

ARTICLE I

Pool and Park Areas

[Adopted 6-24-1953 by Ord. No. 14]

§ 108-1. Hours of operation.

- A. The normal operating season for the pool shall be from Decoration Day to the Monday following Labor Day, but the time of opening or closing for the season may be varied by resolution of the Board of Trustees.
- B. Weather permitting, the pool shall be open for admission from 10:00 a.m. until 7:30 p.m. each day, except that all children under the age of 12 years must be out of the pool area by 5:30 p.m. No one except authorized persons shall remain in the pool or pool area between 8:00 p.m. and 10:00 a.m. The hours of use may be varied by resolution of the Board of Trustees.
- C. Between 10:00 a.m. and 11:30 a.m., except on Saturdays, Sundays and holidays, children under the age of 12 shall, subject to the safety regulations hereinafter set forth in § 108-7B, have the exclusive use of the pool for the purpose of receiving swimming instructions from pool lifeguards upon payment of fees as hereinafter set forth. Swimming instructions to persons 12 years of age or over may be given by pool lifeguards after 5:30 p.m., except on Saturdays, Sundays and holidays, but no such instructions shall be given by a lifeguard otherwise assigned to duty. Swimming instructions will not be permitted at any other time.

§ 108-2. Use by residents.

- A. Residents of the Village of Saddle Rock owning property in said village conforming to the minimum area provisions of the Village Building Zone Ordinance,¹ hereinafter for convenience called "residents," shall have the right to use the pool only on the basis of unlimited seasonal use, the fee for which is described in § 108-4B.
- B. Upon application by a resident and payment of the prescribed fee, a signed identification

card will be issued to each member of his immediate family residing in the village, and a guest coupon book will be issued to such resident. Such card will set forth the name, sex and age of the holder and shall be signed by each holder over the age of eight years. Each person shall, at the time of each entry into the pool area, show his identification card to the pool attendant at the entrance desk and sign the registry book. The pool attendant shall enter the identification card number of such person on the registry book opposite his signature.

- C. Definition of resident. For the purposes of this section and all other provisions of this chapter, the term "resident" shall mean a person who owns and lawfully resides in a dwelling lawfully located entirely within the Village of Saddle Rock, on property having an area located within the Village of Saddle Rock complying with the minimum area provisions of the Village Building Zone Ordinance.² [Added 8-3-1988 by L.L. No. 7-1988]

§ 108-3. Guests.

Residents shall be permitted such guest privileges as may, from time to time, be established by resolution of the Board of Trustees. Upon payment of the fees prescribed by § 108-4B and the presentation of undetached guest coupons, such guests, as permitted by resolution of the Board of Trustees, may use the pool if accompanied by an adult member of the resident host's family. All guests shall, at the time of each entry into the pool area, sign the registry book, and the pool attendant shall enter the guest coupon number opposite such signature.

§ 108-4. Fees.

- A. A resident and the immediate members of his family residing in the village may use the pool and park area only upon payment of such fee per family as shall be determined by the Board of Trustees, but not to exceed \$50 per family, which shall entitle each resident and each such immediate member of his family to unlimited pool use during the season.
- B. Fees for guests shall be as follows:
- (1) Admission to the pool during weekdays.
 - (a) Children under the age of 12 years: \$0.50.
 - (b) Persons 12 years of age or over: \$1.25.
 - (2) Admission to the pool on Saturdays, Sundays and holidays.
 - (a) Children under the age of 12 years: \$1.25.
 - (b) Persons 12 years of age or over: \$2.
- C. Money shall not be collected at the gate, but all entry fees shall be paid through the medium of special coupons purchased for such purpose.
- D. With respect to the admission of guests after 5:30 p.m., they shall be required to turn in a guest coupon with each guest. [Added 6-3-1956]

- E. The fees for swimming instruction shall be arranged with the lifeguard giving the instruction but shall not exceed the sum of \$1 for a one-half-hour lesson.

§ 108-5. Use by employees of residents.

Upon the application of an owner and resident as defined in § 108-2, special employees' passes or identification cards may be furnished to residents' employees or domestics, one such identification card or pass being permitted for each resident owner without additional charge. Such employee's card shall permit the employee entrance to the park area but shall not entitle the employee to use the pool. Each employee shall, at the time of entry into the park and pool area, show his employee's card at the entrance desk and sign the registry book. The pool attendant shall enter the employee's card number of such employee on the registry opposite his signature.

§ 108-6. Sanitation rules.

Every person using the pool is required to be familiar with and to obey the rules promulgated by the State of New York covering the use of pools. A copy of such rules will be posted at the entrance of the pool, and an extract of such rules will be distributed at the beginning of the season to each family registering for seasonal use of the pool.

- A. Every person must take an adequate shower bath before entering the pool.
- B. All females must wear bathing caps when using the pool.
- C. Care must be used to see that all refuse is placed in receptacles provided for that purpose.
- D. Dogs and other animals are not permitted within the pool and park area.
- E. Food is strictly forbidden in the entire pool area, including lockers and locker rooms.

§ 108-7. Safety rules.

- A. No glass containers of any kind are permitted within the pool area. (Sunburn lotions are permitted in plastic bottles and tubes only.)
- B. At all times children under the age of eight years must be accompanied in the pool or pool area by an adult entitled to enter the pool as a resident or guest. Children of eight years and over shall be permitted in the pool unaccompanied by such an adult only upon evidence of ability to swim.
- C. No games of any kind, including card playing, shall be permitted within this pool area, and no toys or athletic equipment other than inflated rubber toys are permitted within the pool area.

§ 108-8. Replacement of identification card.

An identification card claimed to have been lost may be replaced by the Park Commissioner, in his discretion, upon payment of a fee of \$1.

§ 108-9. Miscellaneous rules.

- A. Cars shall be parked in the vicinity of the pool only in the designated parking area.
- B. No person is permitted to enter or leave the park area in a bathing suit or dressing robe, except that dressing robes may be worn if entering or leaving the pool and park area by automobile.
- C. No person is permitted to dress or disrobe anywhere in the pool area except in the locker room provided for that purpose. This applies to children as well as adults.
- D. All rules and regulations adopted by the Board of Trustees pursuant to this Article shall have the same full force and effect as though set forth herein, and any violation of such rules shall be deemed a violation of this Article.
- E. The lifeguards, caretaker and other employees of the pool and pool area are required to enforce these rules and regulations strictly and may not deviate therefrom.
- F. Any identification card obtained by misrepresentation or tendered for the purpose of obtaining admission to the pool by a person who is not entitled to the use of the pool will be picked up by the pool attendant, and, in any such case, the Board of Trustees may cancel the identification card and revoke the permission granted to the holder to use the pool without refund of the fee previously paid.
- G. Any person violating any of these rules and regulations may be barred from use of the pool, and his identification card may be canceled and annulled by the Board of Trustees without refund.

§ 108-10. Rules of conduct.

- A. No disorderly or intoxicated person shall be allowed on the park premises, and no spiritous liquors shall be brought upon the premises, consumed thereon or sold.
- B. No profane, obscene, insulting or abusive language shall be permitted.
- C. No disorderly or noisy conduct or obscene or indecent acts tending toward a breach of the peace shall be permitted.
- D. No disrobing is allowed in toilets.
- E. No person shall mutilate, deface or otherwise damage or remove any of the park property.
- F. No person shall cut, pull or remove any flowers, shrubbery or trees from the park grounds or in any way damage any of the shrubbery or gardens.
- G. No person shall throw or deposit any wastepaper, newspaper, boxes or rubbish of any kind upon park grounds. Rubbish and refuse must be deposited in receptacles provided for such purpose.
- H. Hawking and peddling in the park or within 500 feet of any entrance is prohibited.
- I. No person shall post or distribute any card, pamphlet or circular within the park premises without the consent of the Board of Trustees.
- J. No public meeting may be held within the park premises without the consent of the Board

of Trustees.

- K. Driving golf balls and playing football and baseball, other than softball, is prohibited.
- L. Archery is prohibited.
- M. Bicycle riding in the park area is prohibited.

§ 108-11. Motor vehicles.

No motor vehicle shall be permitted to park, stop or stand at any place in the park, except at the parking area designated for the purpose. No motor vehicle shall be operated in the park at a speed in excess of 10 miles per hour.

§ 108-12. Lost or stolen articles.

The Village of Saddle Rock shall not be responsible for any article of property lost or stolen on the park and pool premises.

§ 108-13. Amendments to rules and regulations. [Amended 12-2-1987 by L.L. No. 8-1987]

- A. The Board of Trustees may, from time to time, adopt and amend regulations and restrictions with respect to use of the pool and park area of the village.
- B. Any regulations or restrictions heretofore issued by the Village of Saddle Rock with respect to use of the pool and park area in the village shall remain in effect until amended or superseded by resolution of the Board of Trustees.

§ 108-14. Penalties for offenses. [Amended 12-2-1987 by L.L. No. 8-1987]

Any person who shall violate any rule or regulation or restriction applicable to the use of the pool and park in the Village of Saddle Rock, whether heretofore adopted or adopted pursuant to the provisions of this Article, shall be guilty of a violation.
